

CAMOPLAST LIMITED WARRANTY DURABUILT RUBBER TRACK Agricultural Usage

Effective August 1 2006

Revised Feb 1 2009

Eligibility

Original owner of new Camoplast parts service track and purchased through an authorized Camoplast aftermarket dealer.

Coverage

Camoplast Durabuilt track is warranted for a period of 24 months / 2000 hours (2500 series), whichever comes first, or 48 months / 4000 hours (3500/5500 series), whichever comes first, against defects in materials and workmanship. Camoplast rubber track that becomes unserviceable as a result of a defect in materials or workmanship will be eligible for coverage. Track eligible for coverage will be (at Camoplast's choice) repaired, replaced, or allowance given towards purchase of replacement Camoplast track. Coverage begins on the track purchase date from an authorized Camoplast aftermarket dealer.

Excluded from Coverage

- Track used in non-agricultural applications
- Track which transmits power through drive lugs (positive drive)
- Factory installed OEM track (OEM track warranty applies)
- Remanufactured track
- Damage from misuse, negligence, alteration, accident, overload, misapplication, use with non-OEM undercarriage components, or resulting from poor mechanical condition/adjustment on the machine
- Minor cosmetic defects, such as surface cracks, splits and other superficial distress that may impact track appearance but does not render the track unusable or measurably diminish overall life
- Usage or installation which Camoplast judges improper

Owner Obligations

- Machine transportation to location used to perform warranty work
- Installation costs
- Freight charges if applicable
- Machine undercarriage components properly maintained

Prorated Replacement

Camoplast Durabuilt track that become unserviceable due to a covered warranty condition, outside of the no charge replacement period, but still in the warranty period, qualify for prorated replacement. The customer portion of the original purchase price is calculated from the customer participation chart using the months of service and the useable tread wear, where:

$$\text{Actual Useable Tread Wear \%} = \frac{\text{New Height} - \text{Average Height}}{\text{New Height} - \text{Wearout Height}} \times 100$$

Track still in use past the stated warranty period, or worn to less than wearout height, are not eligible for warranty consideration.

Replacement Track Warranty Period

Track replaced due to a defect in materials and workmanship during the original track warranty period, and customer participation is less than or equal to 50%, the replacement track warranty period is limited to the remainder of the original track warranty period. Otherwise, the replacement track will carry a full new track warranty.

Installation Allowance

Durabuilt 5500 track that qualifies for warranty reimbursement is eligible for an installation credit. This credit amount is dependent on the machine. Contact your Camoplast dealer for additional details.

Legal Rights

THERE ARE NO WARRANTIES THAT EXTEND BEYOND THE DESCRIPTION PRINTED ABOVE AND CAMOPLAST DOES NOT IN ANY WAY WARRANT THE FITNESS OF THE TRACKS FOR ANY PURPOSE OTHER THAN THE ORDINARY PURPOSE FOR WHICH SUCH TRACKS ARE USED.

ALL WARRANTIES IMPLIED BY STATE LAW, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, ARE EXPRESSLY LIMITED TO THE DURATION OF THE LIMITED WARRANTIES SET FORTH ABOVE. CAMOPLAST'S LIABILITY AND PURCHASER'S SOLE REMEDY, WHETHER IN CONTRACT, UNDER ANY WARRANTY, IN TORT (INCLUDING NEGLIGENCE), IN STRICT LIABILITY OR OTHERWISE SHALL BE LIMITED TO THE REPLACEMENT OF THE TRACKS ON A PRORATED BASIS PER CHART AS STATED ON THE FRONT SIDE HEREOF, AND UNDER NO CIRCUMSTANCES SHALL CAMOPLAST BE LIABLE FOR ANY SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, INCLUDING, BUT NOT LIMITED TO, PERSONAL INJURY, PROPERTY DAMAGE, DAMAGE OR LOSS OF EQUIPMENT, LOST PROFITS OR REVENUE, COSTS OF RENTING REPLACEMENTS AND OTHER ADDITIONAL EXPENSES, EVEN IF CAMOPLAST HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
